## Eligibility Criteria for Recognition as Ph. D. Guide in Arts, Science, Commerce, Management, Law and Education (Other than Engineering, Pharmacy & Ayurveda)

- Only a full time regular teacher of Constituent Colleges / Institutions of CVM University having at least 02 years of P. G. teaching / research / industrial research or a minimum of 04 years of U.G. teaching experience shall act as a Ph. D. Guide and no external Guide shall be allowed. However, Co- Guide may be allowed in inter-disciplinary areas as per the needs with the approval of the duly constituted Research Advisory Committee.
- Any regular Professor of this university with a Ph.D. degree and at least **FIVE** research publications in Peer reviewed refereed journals may be recognized as Research Supervisor. Provided further that the publications must be in the indexed journals of National and International repute with ISSN / ISBN, listed in the UGC list of journals or should be listed in the Web of Science.
- Any regular Associate/Assistant Professor of this university with a Ph.D. degree and at least **TWO** research publications in Peer reviewed refereed journals may be recognized as Research Supervisor. Provided further that the publications must be in the indexed journals of National and International repute with ISSN / ISBN, listed in the UGC list of journals or should be listed in the Web of Science.
- In areas/disciplines where there is no or only a limited number of refereed journals are published, the University may relax the above condition of publications for recognition of a person as Ph. D. Guide with reasons recorded in writing.
- A person recognized as a Ph. D. Guide by other UGC recognised universities upon joining this University, shall be automatically recognised as a Ph. D. Guide in this university.
- A Research Supervisor /Co- Research Supervisor who is a professor, at any given point of time, cannot guide more than **EIGHT** Ph.D. scholars. An Associate Professor as Research Supervisor can guide up to a maximum of **SIX** Ph.D. scholars and an Assistant Professor as Research Supervisor can guide up to a maximum of **FOUR** Ph.D. scholars. Provided further that before recognizing the teacher as a Ph.D. Research Supervisor, duly constituted screening committee, appointed by this university, will scrutinize the potential of the teacher.

## Eligibility Criteria for Recognition as Ph. D. Guide in Engineering & Pharmacy

- A faculty member, to be recognized as Research Supervisor for Ph.D. Programme, should be full time regular teacher of, having Ph.D. degree in the subject or in a related discipline.
- He/she should have a minimum of **FIVE** publications in the Journals of National or International repute having ISSN / ISBN numbers.
- He/she should have at least **08 years** of teaching/research/industrial research experience.
- A Research Supervisor who is a professor, at any given point of time, cannot guide more than **FIVE** Ph.D. scholars. An Associate Professor as Research Supervisor can guide up to a maximum of **THREE** Ph.D. scholars and an Assistant Professor as Research Supervisor can guide up to a maximum of **ONE** Ph.D. scholar. However, students from foreign countries may be in addition to the above numbers, subject to approval from the university.
- A person recognized as a Ph. D. Guide by other UGC recognised universities upon joining this University, shall be automatically recognised as a Ph. D. Guide in this university.
- The University will constitute Research Committees with at least three experts on it to look into the fulfilment of the above criteria before giving recognition as Ph.D. Supervisor.

## Eligibility Criteria for Recognition as Ph. D. Guide in Ayurveda

- Any regular full time teacher of Ayurveda who possesses minimum of Master's Degree in the concerned specialization, having at least **10 years** of teaching experience and having good number of research publication in the journals of national and international repute are eligible as Ph.D. Guide in this university.
- However in certain exceptional cases, if the applicant is lacking required teaching experience but possess research experience duly recognized by CCRAS, Government of India or I.P.G.T. & R.A., Gujarat Ayurved University then he/she may be approved as Ph.D. guide after the scrutiny of the application by the committee and tenure of research experience be added to the regular teaching experience required as per the AAYUSH regulations.
- A Supervisor who is a professor, at any given point of time, cannot guide more than **FIVE** Ph.D. scholars. An Associate Professor as Research Supervisor can guide up to a maximum of **FOUR** Ph.D. scholars and an Assistant Professor as Research Supervisor can guide up to a maximum of **TWO** Ph.D. scholars.
- A person recognized as a Ph. D. Guide by other UGC recognised universities upon joining this University, shall be automatically recognised as a Ph. D. Guide in this university.
- Before recognizing the teacher as a Ph.D. Research Supervisor who meets with the above requirements a screening committee be constituted to scrutinize the potential of the teacher.
